Founded in 1973 Ilkley Literature Festival is the largest and most exciting literary festival in the North of England.

We stage over 200 events, spread across 20 venues, in Ilkley, West Yorkshire during the first two weeks of October each year. A packed 17 days attracts around 24,000 people to talks, authors' events, workshops and master classes, literary walks, poetry readings, performances, a free Festival Fringe and a huge range of special events for children and their families.

We even have events just for teenagers, who take part in their own WordsFest, perform at our 'Cool Voices' night and help create a Festival newspaper in a day.

When the Festival is over, our activities continue throughout the year with our 'authors in schools' programme; our weekly young writers group, our regular young peoples' club nights, our Winter lecture series and a whole range of special projects with groups across the community.
